Field experience in governement authorities is a special kind of educational activity which takes place in senior years and requires a preliminary preparation of the students in

- <u>the legal</u>
- <u>analitical,</u>
- <u>communicative</u>
- documentation directions

What does field experience give the student? (the analysis of the questionnaires)

- to acquire and systematize knowledge in the legal sphere;
- the ability to gather and analyze statistical data, meet with citizens and to draft responses to their applications;
- the opportunity to gather information for their semester papers course and diploma works
- most importantly, the majority of the students receive the invitation to work in these agencies.

But...

 not always the authorities are interested in the students since the high tempo and level of responsibility impose greater demands on their work, in other words, the authorities can function without interns.

What to do?

- if field experience is properly organized, it can be very interesting and useful for both sides
- field experience instructors frequently serve as experts of the students' research
- Joint research with the university also contributes to the development of management bodies.

Thus, based on the results of a joint examination of the institutions, the teaching staff of the Department were awarded by the Minister of social development

General conclusions

- this type of field experience must be included in the educational standard of teaching both bachelors and masters in social work";
- field experience in the management bodies settings should be carried out in the last years of training;
- the duration of this type of field experience should be not less than 1 month;
- it is necessary to agree with field experience agencies on the content and requirements for students;
- to prepare the students for field experience during the theoretical classes;
- the development of the algorithm of field experience and the documentation requirements for the students.
