The objectives of the educational practice "Medical familiarization practice" are:

- acquaintance with the structure and organization of the hospital;
- acquaintance with the work of departments, diagnostic and treatment rooms, nosocomial pharmacy;
- studying the design of prescription sheets, rules for discharging, receiving, storing and dispensing medicines to patients;
- acquaintance with the packages of medicines and available leaflets (in the amount of medicines available at nursing posts, in a nosocomial pharmacy, etc.);
- acquaintance with the primary skills in caring for patients and performing some nursing manipulations, in particular, acquiring the skills of opening ampoules, vials, practicing the technique of drawing drugs into a syringe;
- Acquisition of skills in caring for seriously ill and injured people (skin care and prevention of pressure sores, change of underwear and bed linen, delivery of the vessel and urine collection bag, help with eating);
- acquisition of skills in the treatment of premises with disinfectants;
- familiarization with the nature of sanitary education in a medical institution.
- mastering the principles of medical ethics and deontology.

Medical familiarization practice provides for the introduction of students with the structure of a multidisciplinary medical institution and a nosocomial pharmacy, monitoring the general condition of patients with various diseases and injuries, performing the simplest medical procedures and patient care measures.

9. Методические указания для обучающихся по освоению дисциплины

During the internship, students are required to:

- follow the established work schedule and follow the instructions of the practice leaders;
- observe the protective and sanitary regime of the medical institution;
- daily record the results of work in the diary, certifying them with the signature of the responsible person;
- in the last entry in the diary make a summary in which to highlight the main re-sults of the practice;
- pass the test for the practice of the teacher of the department in due time.

The student has the right:

- get acquainted with the work of the departments of the medical institution;
- familiarize yourself with medical documentation (prescription sheets, medication logs, etc.) to the extent necessary to complete the practice program;
- discuss the questions of interest with the heads of the practice.

During the internship, the student must keep a "Diary of Medical familiarization practice".

During the period of restrictive measures that prevent the conduct of educational practices in the educational process in the usual manner (self-isolation, quarantine, observation), in order to carry out educational practice in providing first aid, the educational institution establishes a special distance learning mode. At the same time, the main task of educational practice is to acquire professional skills and abilities, provided with the help of remote technologies: mastering the material by providing assignments and monitoring them through Internet resources, group and individual consultations using both e-mail and visual communication based on online platforms providing text, voice and video communications over the Internet. In this case, the reporting document for practice will be a "report".

For students from among the disabled and persons with disabilities, on the basis of their written application, the organization of practice is implemented taking into account the characteristics of psychophysical development, individual capabilities and health status of students. At the same time, compliance with the following general requirements is ensured: the use of special technical training aids for collective and individual use, the provision of assistant services that provides such a student with the necessary technical assistance, ensuring convenient access to buildings and premises where practices are held, other conditions without which it is impossible or difficult to pass practice. The choice of places for internship for people with disabilities and persons with disabilities is made taking into account the requirements of accessibility for students and the recommendations of medical and social expertise, reflected in the individual rehabilitation program for a disabled person. When sending a disabled person or a person with disabilities to an organization, for the internship, the manager agrees with the organization the conditions for its passage and types of activities, taking into account the

recommendations of the medical and social examination and the individual rehabilitation program for the disabled. To master the theoretical part of the practice, disabled people and people with disabilities are given the opportunity to use electronic technologies, remote mastering of material by providing assignments and monitoring them via the Internet, as well as individual consultations using both e-mail and visual communication using Skype. When performing the experimental part of the practice, additional means of protection are provided as necessary, individual assistance of educational support personnel is provided, as well as other measures taking into account the nosologies of the disease of students. The format for the protection of reports on practice for persons with disabilities and persons with disabilities is established taking into account their individual psychophysical characteristics (orally, in writing, using electronic or other technical means). In the process of defending the report on practice, a student with disabilities has the right to use the technical means necessary for him. For the visually impaired, a portable video enlarger can be provided, it is possible to use your own devices. For deaf and hard of hearing students, sound amplifying equipment can be presented, it is possible to use equipment for individual use. At the request of a student with disabilities, in the process of defending the report on practice, the presence of an assistant who provides the student with the necessary technical assistance, taking into account his individual characteristics, can be provided. If necessary, persons with disabilities and persons with disabilities may be given additional time to prepare responses when defending practice reports.
